1. Getting Started

1.1 Launching EEX Group DataSource Desktop App

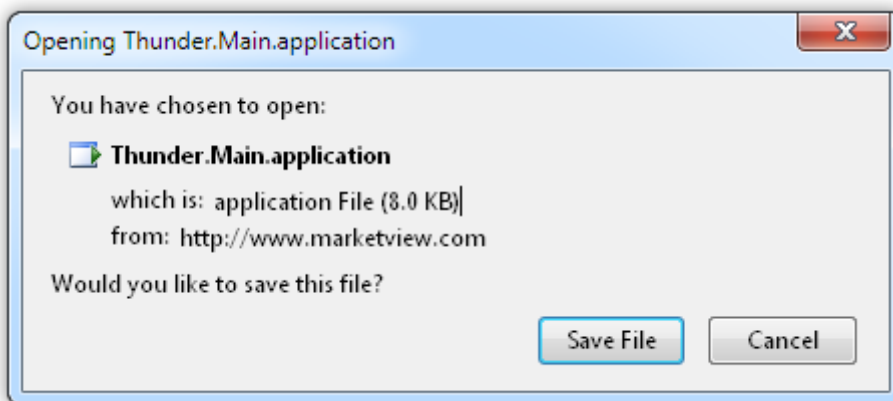
Follow the steps below to launch the EEX Group DataSource Desktop App

1. Click on the following link:

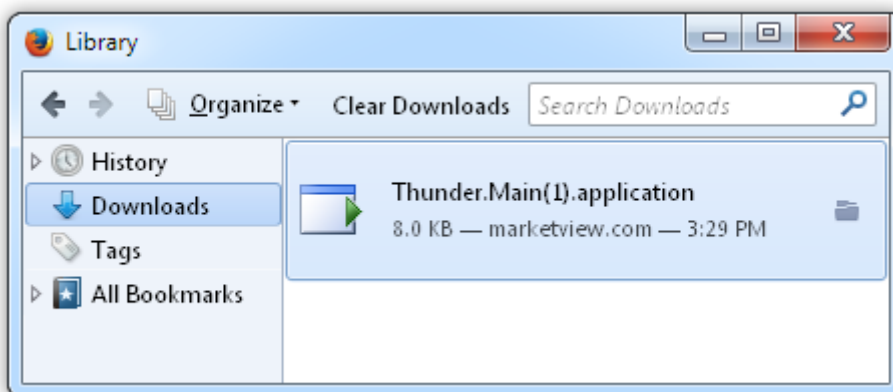

2. Save the file Thunder.Main.application



3. Double click on the download

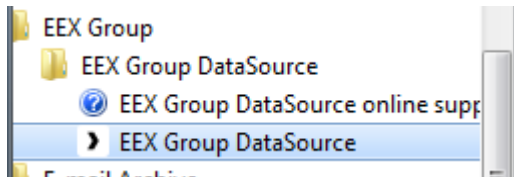


4. The login box will appear next.



You will only have to go through this process once. After the EEX Group DataSource Desktop App has been launched once it installs a short cut in the start menu.

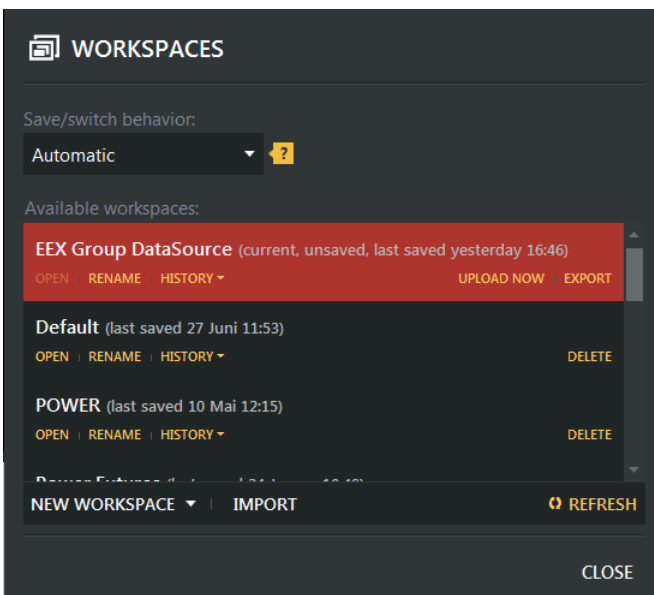
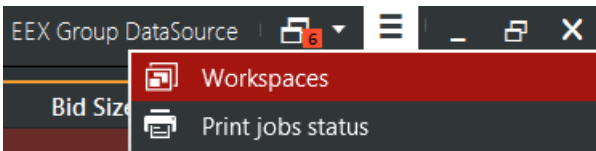

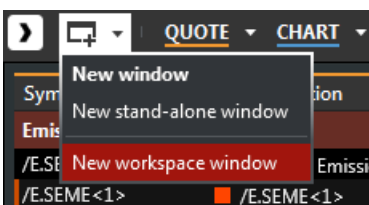
1.2 EEX Group DataSource Workspaces

Customers are provided with one workspace which includes several pages with EEX Group commodities and EEX Transparency Data. This preset can be amended or even deleted by the customers. Customers can create new ones. Exporting of data allows to save the configured workspace, to import it again or to send it to other users.



Multiple Workspace Windows

Multi-monitor setups can now be better utilized with additional workspace windows.



2. Symbols

2.1 Symbology

Symbology is the interpretation of how symbols are configured. Knowing the symbology, will assist you when creating a quote query or when configuring an historical table.

Formatting EEX Group Market Data

EEX Group Market Data Symbols are composed as follows:

/E.PRODUCTCODE FOR EMISSION SPOT AND ALL FUTURES

-E.PRODUCTCODE FOR OPTIONS

#E.PRODUCTCODE FOR GAS SPOT

\$E.PRODUCTCODE FOR INDICES

#EEXT.CODES FOR TRANSPARENCY DATA

- EEX Group Market Data Symbols for Spot and Futures contracts are prefaced with a /E. followed by the root, month code, then year.
- EEX Group Market Data Symbols for Options contracts are prefaced with a -E. followed by the root, month code, then year.
- EEX Group Market Data Symbols for Gas Spot contracts are prefaced with a #E. followed by the root.
- EEX Group Indices Symbols for Agriculture and APDD are prefaced with a \$E. followed by the root. The remaining EEX Group Indices Symbols are prefaced with a #E. followed by the root.
- EEX Transparency Data are prefaced with a #EEXT. followed by the root for time series. Events will be available as News.

Example:

- /E.DEBMH19 where
 - DEBM = Phelix DE Base Load Month Futures
 - H = March
 - 19= 2019

NOTE: The /E. in front of the symbol root specifies the EEX Group trading session.

Rolling Futures: Rolling futures symbols automatically change the contract on contract expiration. A nearby for the EEX Group session is the root preceded by '/E.' and followed by <numeric month out>.

Examples:

- /E.DEBM<0> Phelix DE Base Load Month Futures – Current Month
- /E.DEBM<1> Phelix DE Base Load Month Futures – Front Month
- /E.DEBM<2> Phelix DE Base Load Month Futures – One Months Out

Rolling Futures – Alias: An alias represents the current contract and will change as the contracts roll. An alias is the root preceded by '/E.' and followed by [numeric month out].

Examples:

- /E.DEBM[0] Phelix DE Base Load Month Futures – Front Month. NOTE: On a QUOTE query, /E.DEBM<0> and /E.DEBM [0] will return the same data
- /E.DEBM[1] Phelix DE Base Load Month Futures – Front Month

Rolling Futures – Continuous Months: (HISTORICAL QUERY ONLY) Rolling futures symbology for a particular delivery month is the root <month>. (Note the month is entered by its first three letters and is not case sensitive.) This pulls the most current trading contract. To access a month beyond the most current month, use the root <month +number of years out>. Both symbologies follow similar formats for different symbols.

Examples:

- /E.DEBM<JAN> Phelix DE Base Load Month Futures January
- /E.DEBM<JAN+1> Phelix DE Base Load Month Futures 2nd January out continuous
- /E.DEBM<JAN+2> Phelix DE Base Load Month Futures 3rd January out continuous

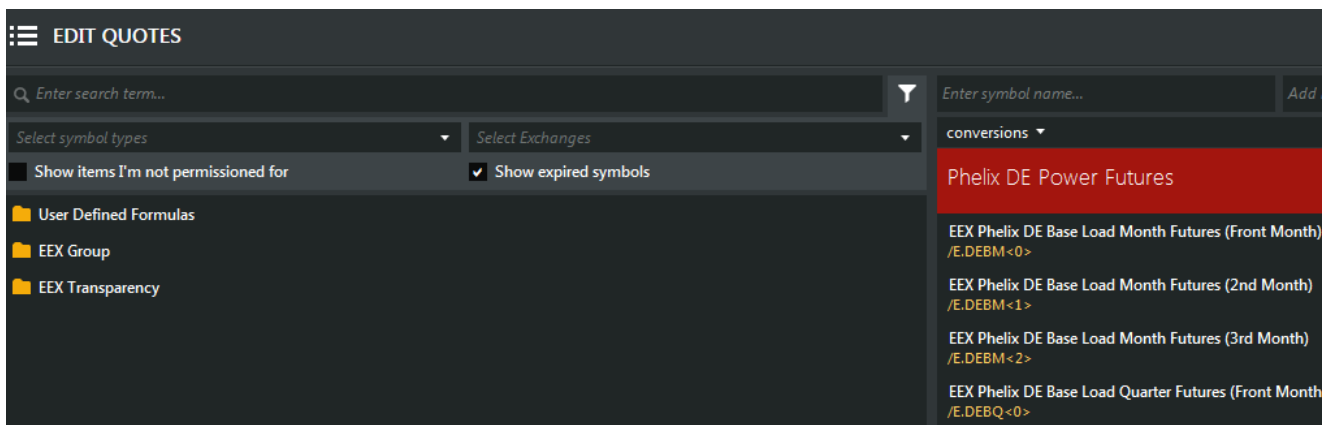
2.3 Symbol Search

The Symbol box allows you to enter a word or phrase to assist you in finding the desired symbols. Enter the word or phrase in the top left part of the component where it says “Enter symbol...”. The results are displayed in a drop down directly below the symbol box.

1. To start, click on EDIT within the component chosen

- Next, enter a part of the symbol’s description, such as “Phelix” in the search box where it reads “enter search term...”



As you continue to enter more letters in the Search box, the results are screened more finely.

- To select ONE contract, double-click on the desired symbol to move it into the Selected Symbols box on the right.
- To select MULTIPLE symbols, hold your CTRL key, and click on each symbol. When you have all of the desired symbols selected, press the ENTER key to move the range to the right side.
- To select a RANGE of symbols, hold your SHIFT key, and click the first symbol in the range you want. Then, click the last symbol in the range. (All of the symbols in the range will be highlighted). Press the ENTER key to move the range to the right side.

NOTES: The Symbol Tree remembers the last exchange/category you navigated and will display your most recent symbol choices next time you access the dialog box.

Symbols MAY be added to the right “selected symbols” box multiple times. This allows you to add the symbol to your spreadsheet using different units of measure or currencies. This is helpful if you wish to view the price data for one symbol using different currencies or units of measure

2.4 The symbol Tree

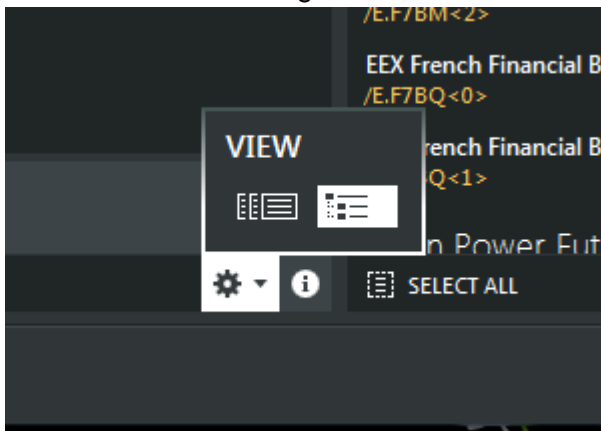
The Symbol Tree/Slider allows you to scroll through all the available exchanges and data categories to find the symbols you want for your query. It will also display any User-Defined Formulas saved. The Symbol Tree is accessed through the Edit Dialog Box, and has a number of settings available.

Settings

You have the option of changing the amount of data to display and the way in which the tree appears by accessing the settings.



1. Click the Settings icon.



2. Click on the desired **View**.

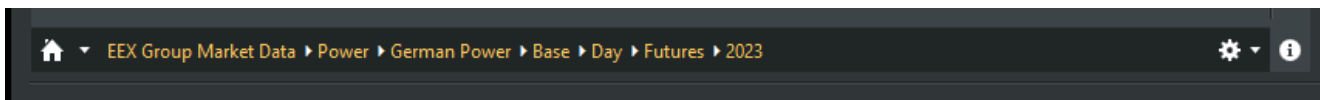
3. Filters:

1.Show items I'm not permissioned for: When CHECKED, you will see ALL symbols, even those for exchanges you are not permissioned to receive. If you add an unpermissioned symbol to your query, no data will be returned.

2.Show expired symbols: When CHECKED, you will see ALL symbols, even those that have expired. If you add an expired symbol to your query, not data will be returned.

Finding Symbols in the Tree/Slider

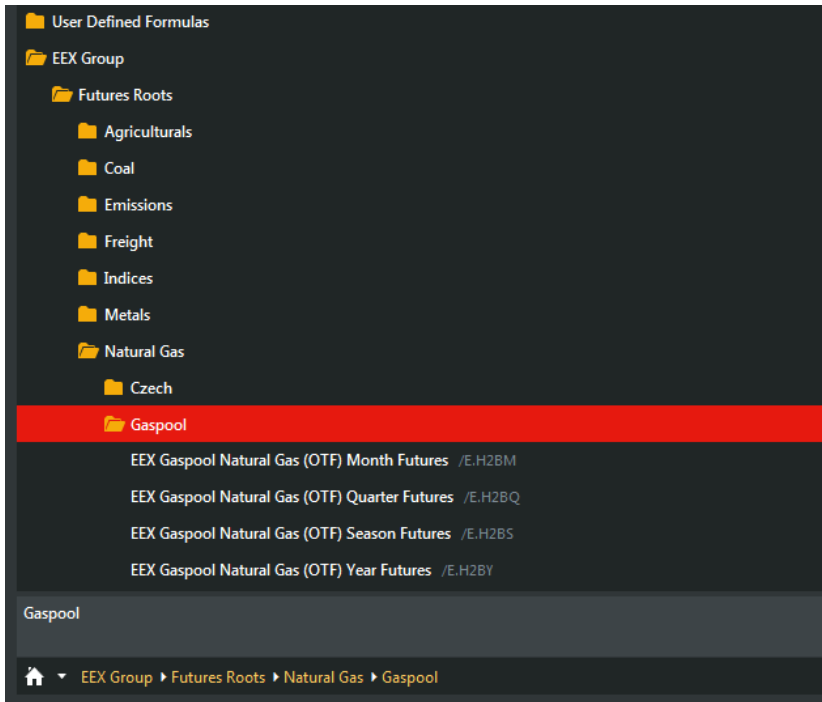
Symbols are grouped by exchange or category. Your Filter settings will be shown at the bottom of the tree:




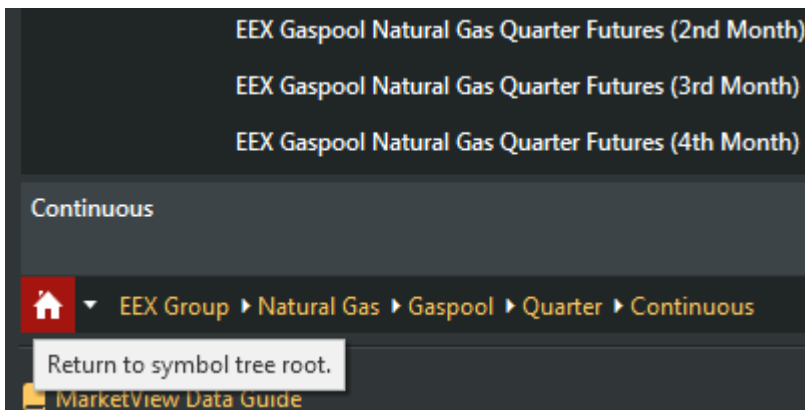
You may change your Filters by clicking on the **Settings icon.** 

In the example below, we've drilled down to **Gaspool**. To see other the commodities found in EEX Group, **double-click** on the name-. The Symbol Tree opens to show you the commodities included. **Double-click** on the desired commodity.

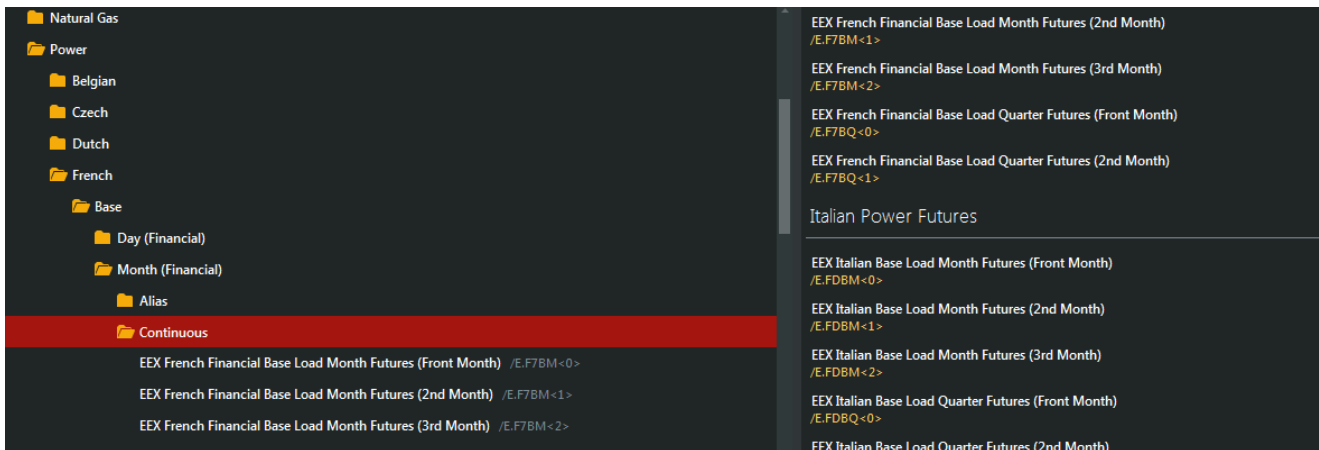
Tree View – (“Windows-styled” folders)



You can always move BACK one step by clicking the < arrow, or go all the way back to the start of the Tree by clicking the  HOME button:



Continue through the tree until you find the symbol you want. To move it to the box on the right (your selected symbols), **double-click** on the symbol or simply click on it once and then press ENTER



To select **MULTIPLE** symbols, hold your **CTRL key**, and click on each desired symbols. When you have all of the desired symbols selected, press your **ENTER key** to move the range to the right side of the dialog box.

To select a **RANGE** of symbols, hold your **SHIFT key**, and click the first symbol in the range you want. Then, click the last symbol in the range. (All of the symbols in the range will be highlighted). Press your **ENTER key** to move the range to the right side of the dialog box.

The Symbol Tree remembers the last exchange/category you navigated, and the next time you initiate a Quotes, Chart, or Historical query it will display your most recent symbol choices.

3. Quotes

3.1 Quote Process

The EEX Group DataSource real-time Quotes interface gives you access to all of your energy publication data as it happens. When you initiate a Quote query, EEX Group DataSource displays a tabular representation of the real-time streaming data for the contracts you've identified. Data is displayed in each column based on the field choices you make when you set up the query.

The process of adding a Quote query to your EEX Group DataSource page is simple: specify the desired symbols and select the data fields you want. Once the query is set, new data is automatically updated into your page.

Follow these steps:

- Initiate a Quote query by clicking on the Quote icon.
- Select symbols to display.
- If you know the specific symbols, enter them directly.
- If you don't know the specific symbols, use the **Search** or **Symbol Tree** to find them.
- Identify the columns / data fields you wish to display using the **field selector**.
- Choose additional display settings (grid style, fonts, and colors).

3.2 Selecting Quote Data Fields

Data fields are used to specify the data that will be placed in each column. The process for selecting fields and their definitions are listed below.

Process for selecting fields:

1. Create a **Quote** query
2. Right click on the top row which contains the default fields.
3. The Quote field dialog box will then pop up.



4. Check or uncheck the box next to the field you would like to add or remove.
5. See **Field Definitions** for a detailed description of each field.
6. Click the **X** to close the Quote field dialog box.
7. Save your changes.

3.3 Quote Field Definitions

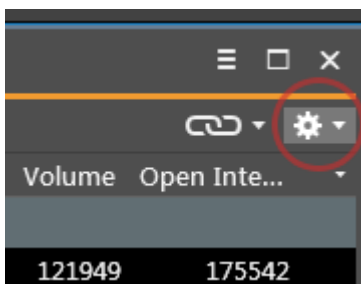

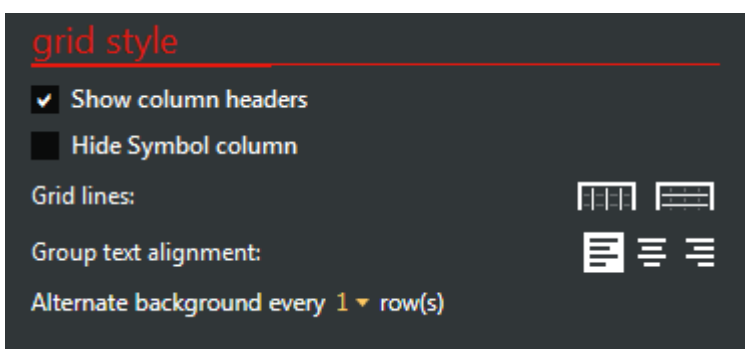
3.4 Quote Preferences

When creating a Quote query, you may choose display options by clicking on the cogwheel found in the upper right corner.



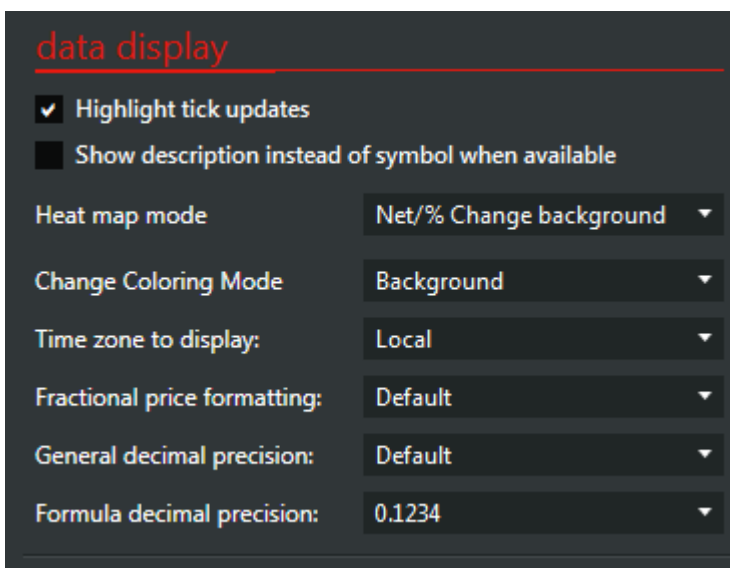
Grid Style

- Show column headers – When checked the field ID’s are shown at the top of each column. Remove the check mark and the field ID’s are removed.
- Grid lines – The first selection is for vertical lines separating each column while the second image on the right is for adding horizontal lines separating each row.
- Alternate background – Controls how often the background color of each row changes.



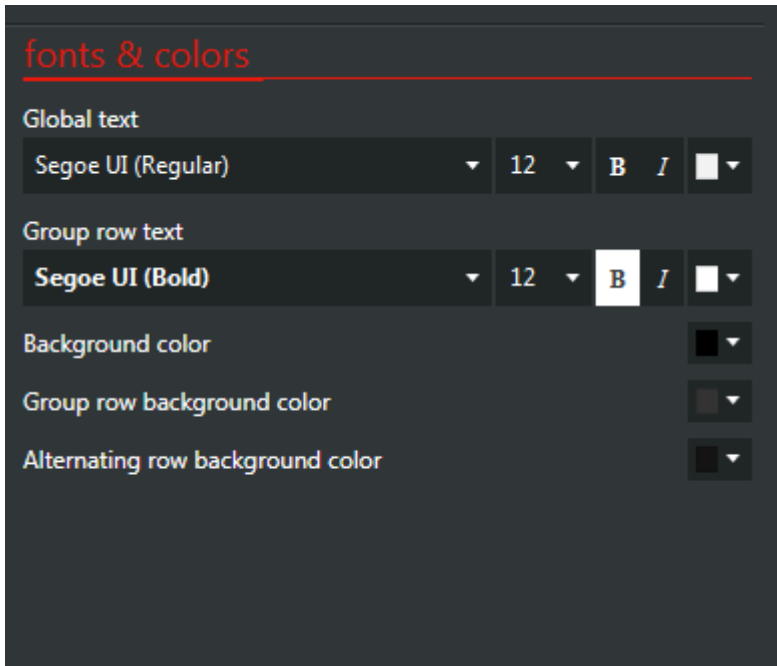
Column Style

- Heat map mode
 - Disabled:

- Date/Time mode – Select the time zone you want displayed, UTC or your local time zone.
- Highlight tick updates – Any time a number changes in your table the background behind that cell will flash yellow.
- Show description instead of symbol when available – Select this to show the symbol description in the 'symbol' field.



Fonts and Colors

- Global text – Controls text format for all text in that window.
- Group row text – Controls the text format for grouped symbols.
- Background color – Changes the background color for that entire window.
- Group row background color – Controls the background color for grouped symbols.
- Alternating row background color – When alternating rows is selected this is the color that is used.

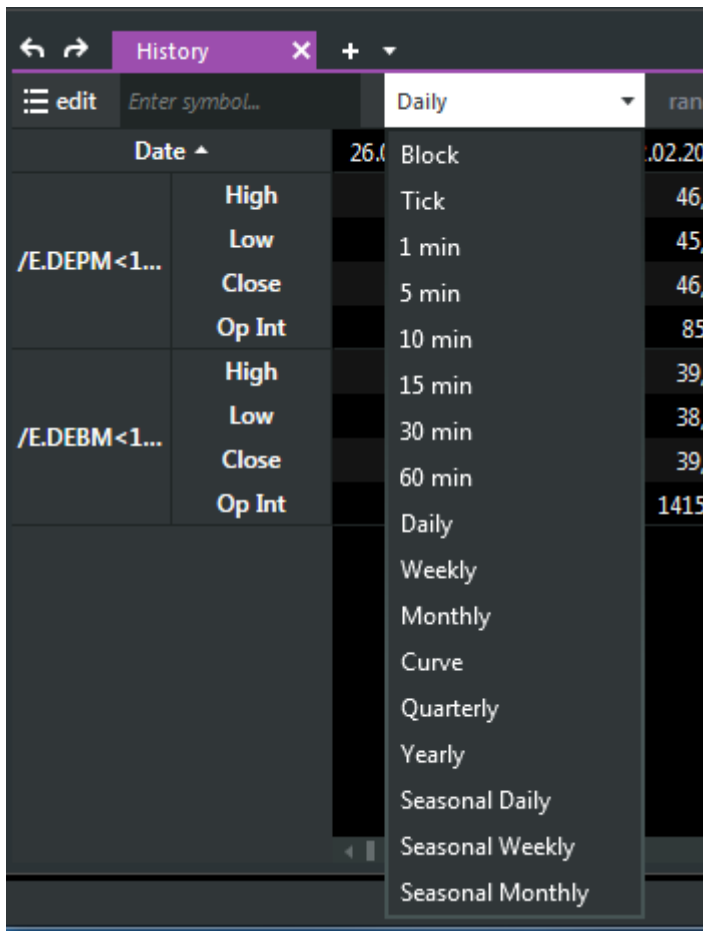
4.1 History Process

The EEX Group DataSource Historical Data interface allows you to create historical data tables with automated data filling methods, and optional unit and currency conversion.

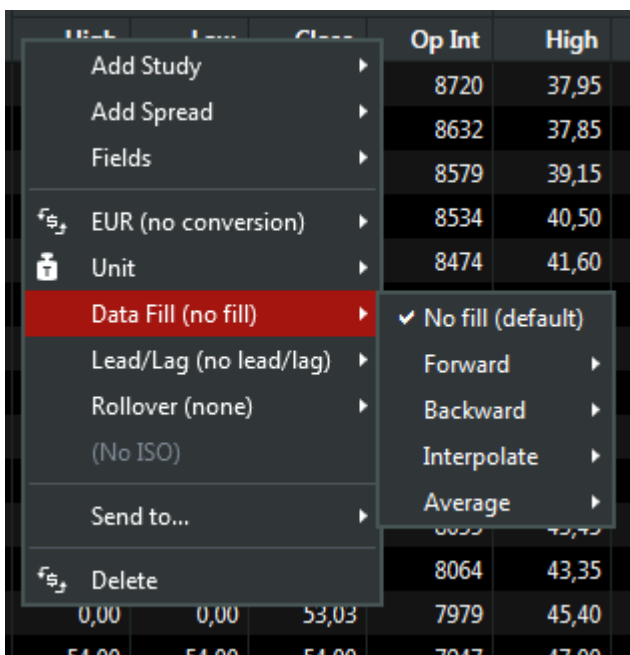

The process of adding a historical table to your EEX Group DataSource page is simple: specify the desired symbols and select the data fields you want. Once the table is set, new data is automatically updated into your page.

- Initiate the query by clicking on the history icon.
- Select symbols to display.
 - If you know the specific symbols, enter them directly.
 - If you don't know the specific symbols, use the **Search** or **Symbol Tree** to find them
- If desired, set **currency or unit of measure conversions** for symbols.
- Identify the **data fields** you wish to display using the field selector.
- Identify the **Time Series** of data you want displayed (Tick, Intraday, Daily, Weekly, Monthly, Quarterly, Yearly, Seasonal)



- Select a **data filling** option



- Optionally chose **Preferences** for the query to edit display settings such as gridlines, colors, and fonts.
- Pages are automatically saved after each click.

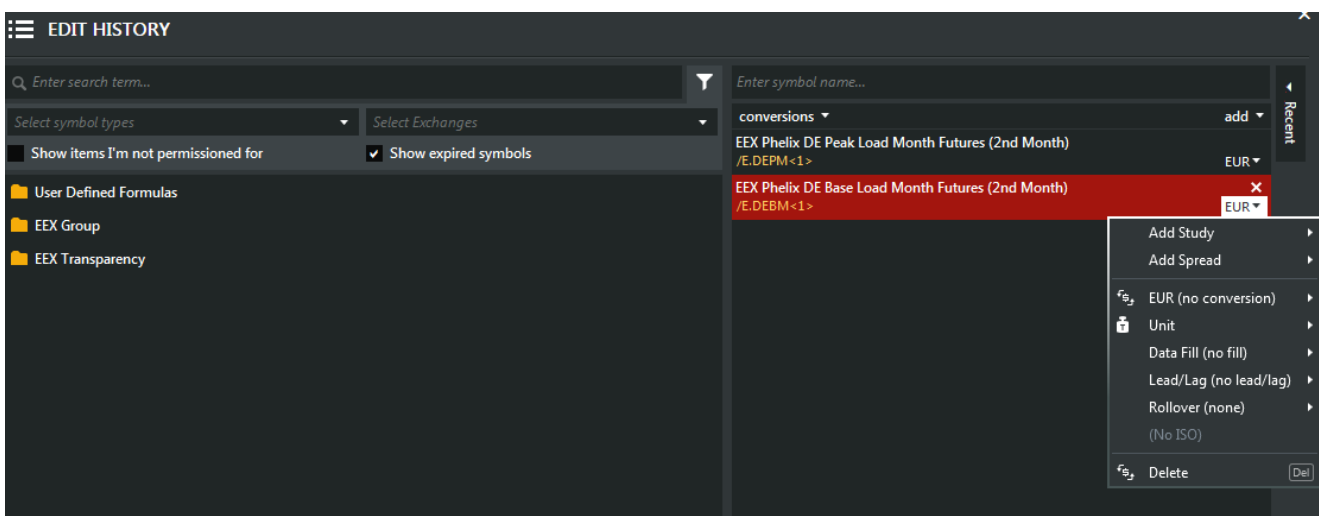

4.2 Currency / Unit Conversion

Unit and currency conversions are available in the History dialog. However, they are not supported for intraday history. Unit and currency conversions are available on a per-symbol basis. Change the unit or currency by clicking on the down-arrow that appears in the selected symbols area of the History dialog box:



Any symbol whose **unit of measure** or **currency** has been changed to one other than its default will show the new unit of measure and currency in its description on the spreadsheet-

Currency Conversion

Currency conversions may only be applied to symbols that have a currency designation stored on the price server. For symbols that do not have a currency designation, the currency unit of measure will not display.

The drop-down list allows you to select the target currency to be used in converting price values for the selected symbol. The default value in the list reflects the original currency assigned to the selected symbol.

The currency conversion checks the conversion rate between the two currencies for the date of the historical record and the exchange selected.

Unit Conversion

Unit conversions may be applied to symbols that have a base unit of measurement stored on the price server. For symbols that do not have a base unit of measurement, the unit of measure will not display.

The drop-down list allows you to select the target unit of measure to be used in the historical display for the symbol. The default value in the list reflects the original unit of measure assigned to the symbol.

The factor being used in the unit conversion will fill in with a default value supplied by the exchange in which the symbol came from but you can manually override that value just by typing in the factor box.

Lead/Lag

To shift the date the data is displayed on for a symbol enter a positive or negative number in the SHIFT box. Then, select whether you would like to shift the data by calendar, quoted, or week days.

Rollover

To shift the expiration date of a symbol select whether you would like to shift it by a certain number of days or if you would like it to match another symbols expiration date. A second box will then appear were you can enter a number of days or select the symbols expiration date you want to match.

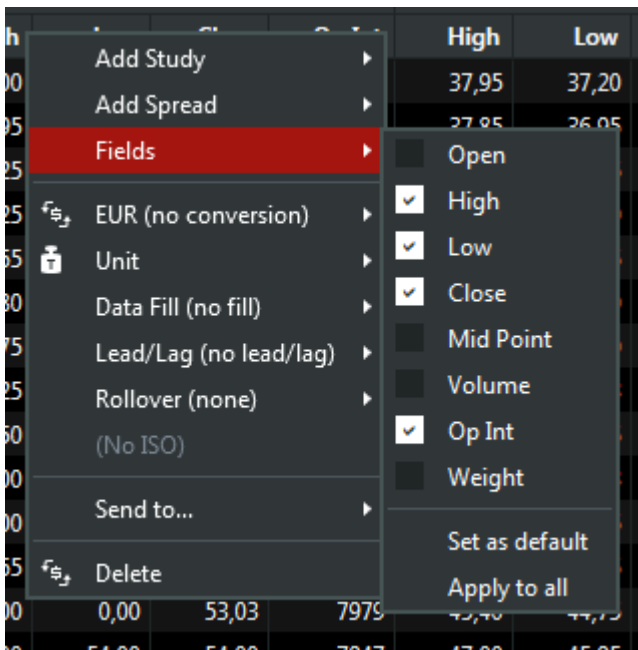
Note: Use SELECT ALL and the conversions button at the bottom of the edit history box to apply unit and/or currency conversions to all symbols within the table.

4.3 Selecting Historical Data Fields

Data fields are used to specify the data that will be placed in each column. The process for selecting fields and their definitions are listed below.

Process for selecting fields:

1. Create a **Historical Data** Table.
2. Right click on the top row which contains the default fields (close).
3. The Historical field dialog box will then pop up.



4. As you click on each field it will be add to your table or vise versa click on a field to remove it from the table.
5. Apply to all will make the fields for each symbol uniform.
6. Set as default will use this field selection for new tables created going forward.

4.4 Filling Missing Data

The data filling setting determines what data (if any) should be inserted in the table when there is no reported data from the exchange for a specific date. Missing data typically occurs when a holiday falls mid-week.

1. Create a **historical table**.
2. Place a check mark in the data filling box to open more options.
3. Select how you would like the data to be filled in.
4. Set the frequency in which you would like the data filled.

Data Filling Options

- Fill Forward – Cells with missing data will be populated with the previous session's closing values. (default)
- Fill Backward – Cells with missing data will be populated with the next session's opening values.
- Interpolate – This option will fill any missing data in a data series by calculating the average using the previous and next values in the series. This option will not fill blanks at the beginning or end of the data series.
- Leave Blank – Cells will be left blank when no data is present for the time series. Uncheck the data filling box for this option.

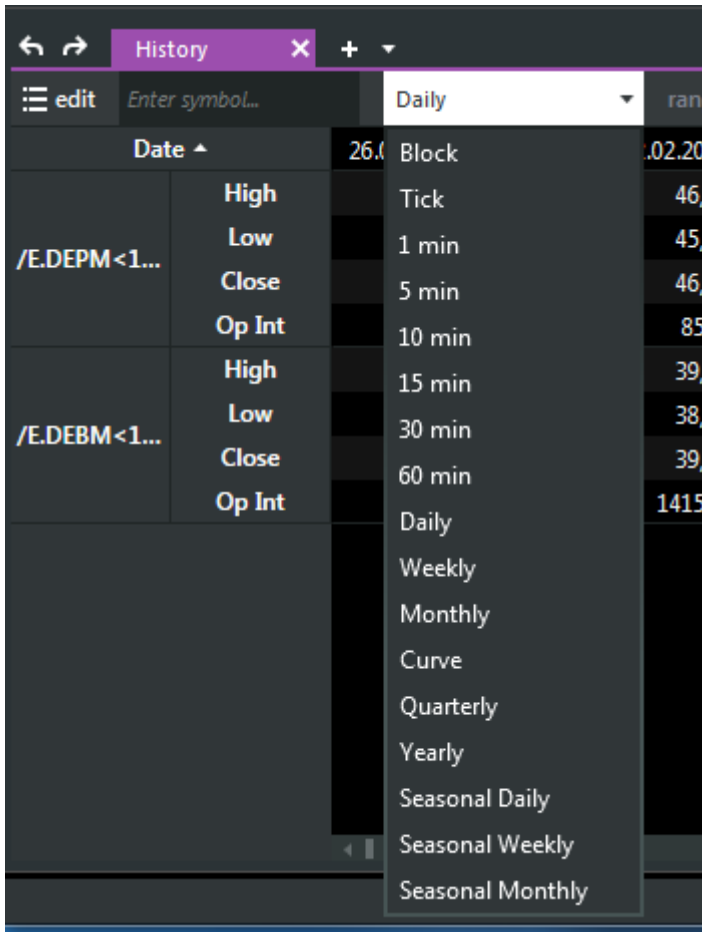
Data Filling Frequency

- Business – Fills only dates missing data that occur between Monday – Friday.
- Six-day – Fills dates missing data that occur between Monday – Saturday.
- Daily – Fills dates missing data 7 days a week.

4.5 Historical Time Series

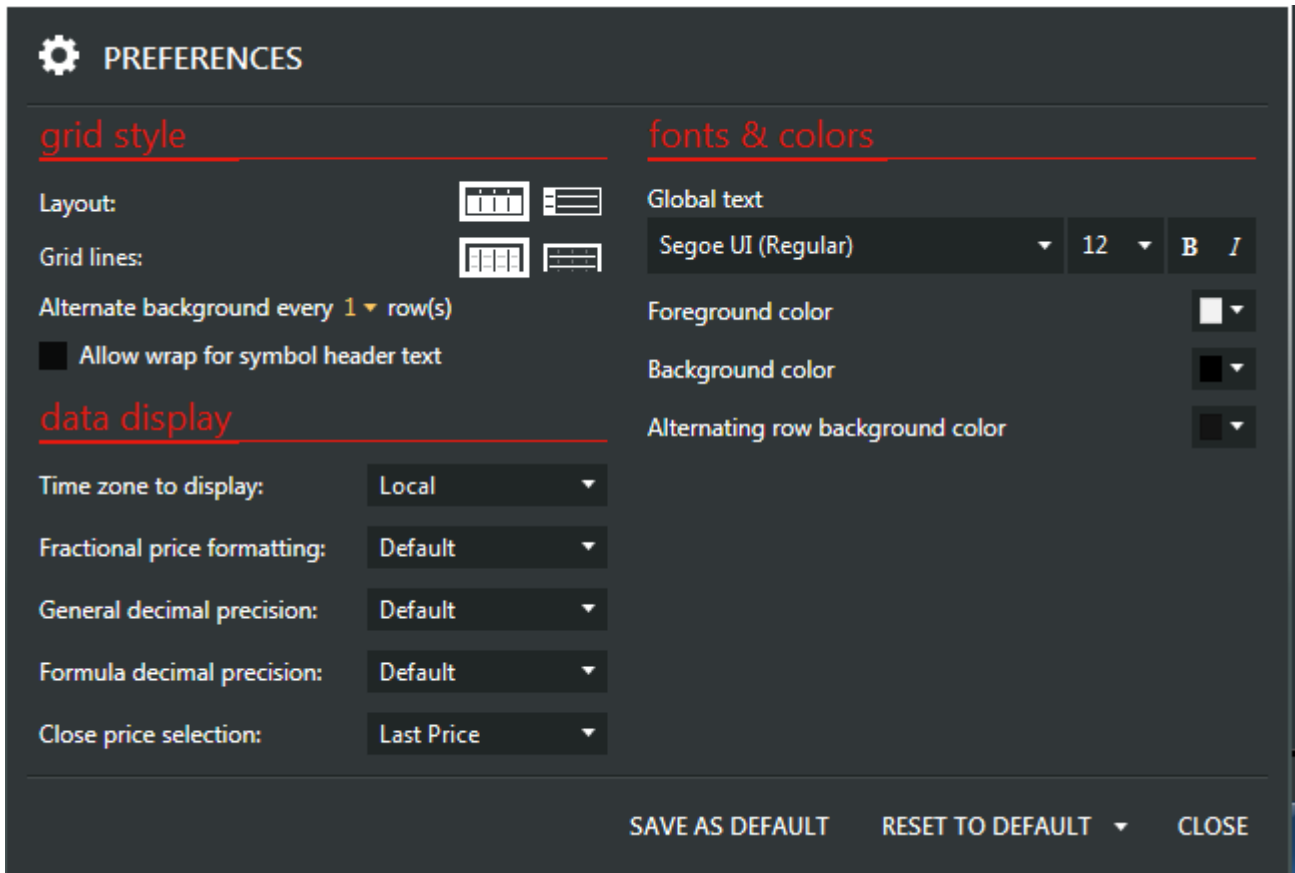
The time series drop down and date range feature can be used to display the data you need.

Simply click the down arrow and select the frequency in which you would like the data displayed. Keep in mind the symbol and exchange you are looking at. Many symbols only have one end of day prices so viewing a 1 minute table would not apply.



4.6 History Preferences

Use the preference settings to customize the look of your table.



Click on the cogwheel in the upper right hand corner of your window to open the preferences dialog box.

- Grid line visibility – Insert grid lines horizontally, vertically, or both ways.
- Grid color – Set a background color for the entire table.
- Text color – Change the color of the text within the table.
- Alternating row color – Secondary background color for alternating rows in the table.
- Alternate background every “X” row(s) – Select how often you want the rows to change colors.
- Grid font – Edit the style of text in your table.

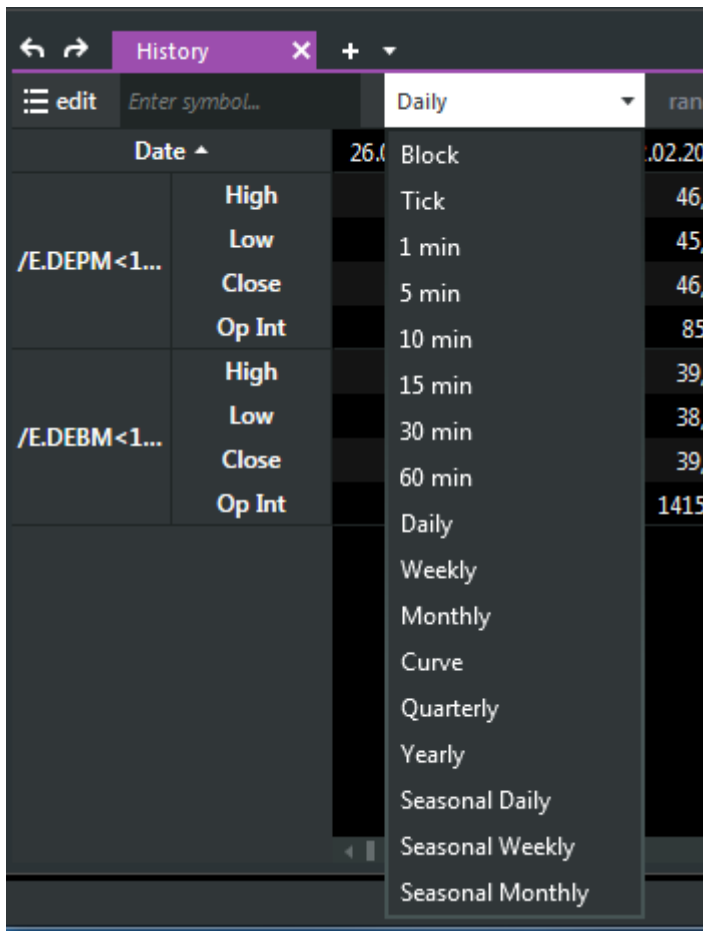
5.1 Chart Process

The EEX Group DataSource Chart component allows you to create a graphical chart of historical data which will automatically update. You can select from numerous time series (intraday, daily, weekly, monthly, quarterly, yearly, or seasonal) and also from numerous chart types (open, high, low close, midpoint, volume, candlestick, and bar chart).

The process of adding a Chart to your EEX Group DataSource page is listed below. Specify the desired symbols and select the data fields you want. Once the table is set, new data is automatically updated into your page.

- Initiate the query by clicking on the Chart icon.

5.2 Chart Type and Color

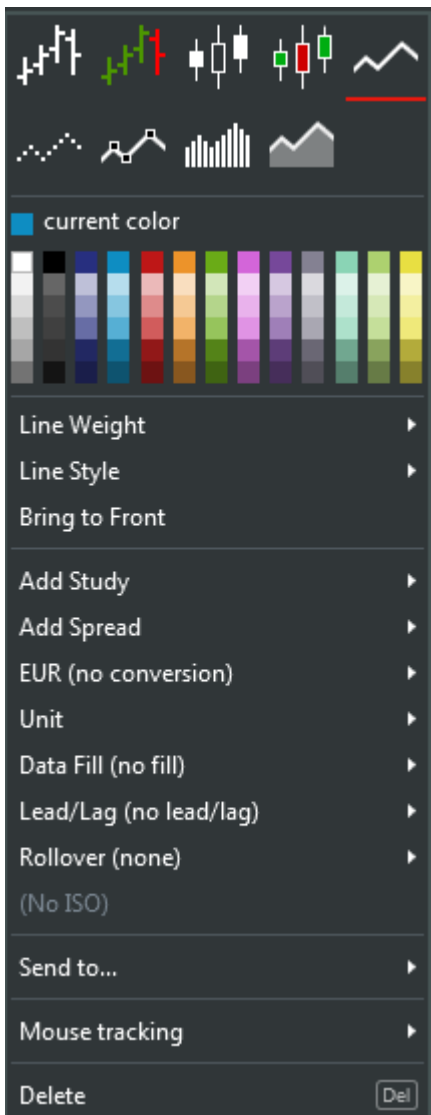

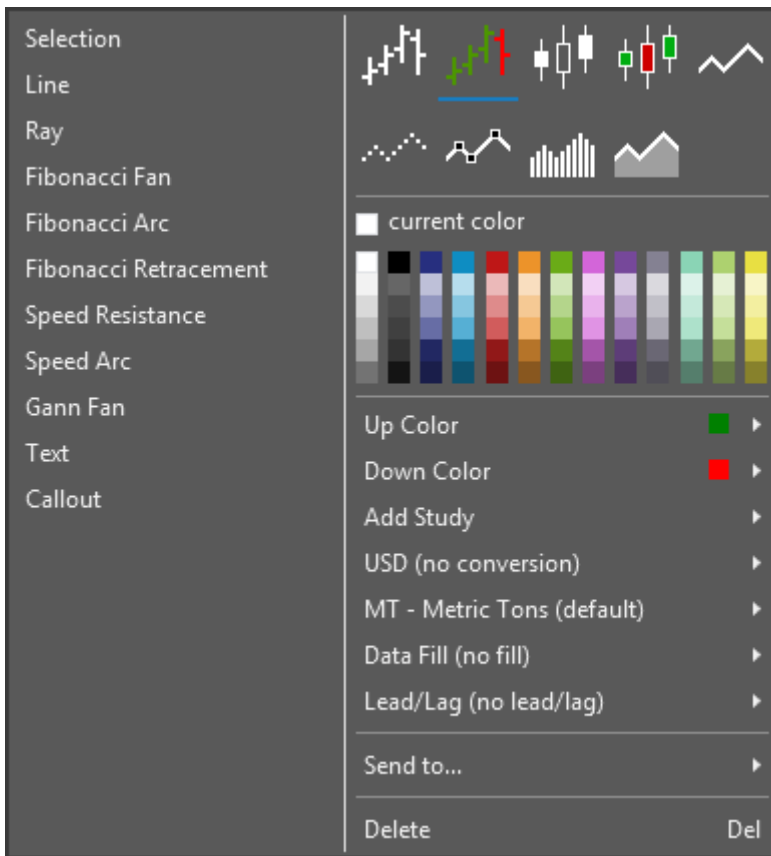

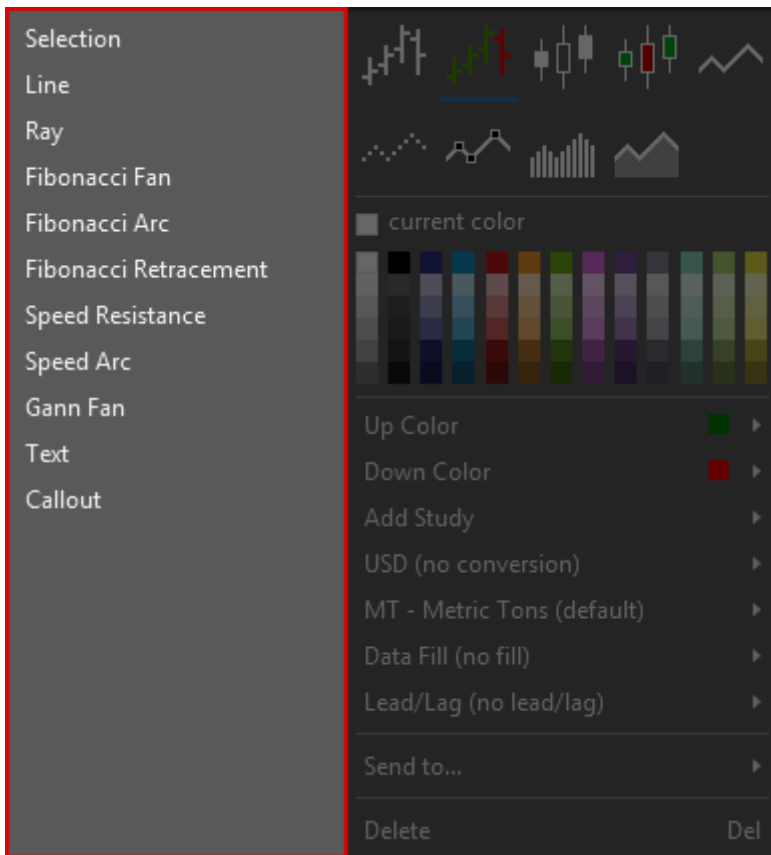

5.3 Trendlines

MarketView charts support the use of both free-form and calculated trendlines. Trendlines are applied and managed in charts via the drawing toolbar.

Editing Trendlines

Edit trendlines by selecting the mouse cursor  from the drawing toolbar. Then select the desired trendline using a single left mouse click on any of the visible handles or square boxes on each end of the primary line. The trendline's size and position is then adjusted by using the left mouse button and "dragging" the primary line's end point to a new location. The trendline redraws to reflect the new coordinates of the primary line.

Moving Trendlines

Move a trendline by selecting the mouse cursor  from the drawing toolbar. Then click and drag the desired trendline into its new position.

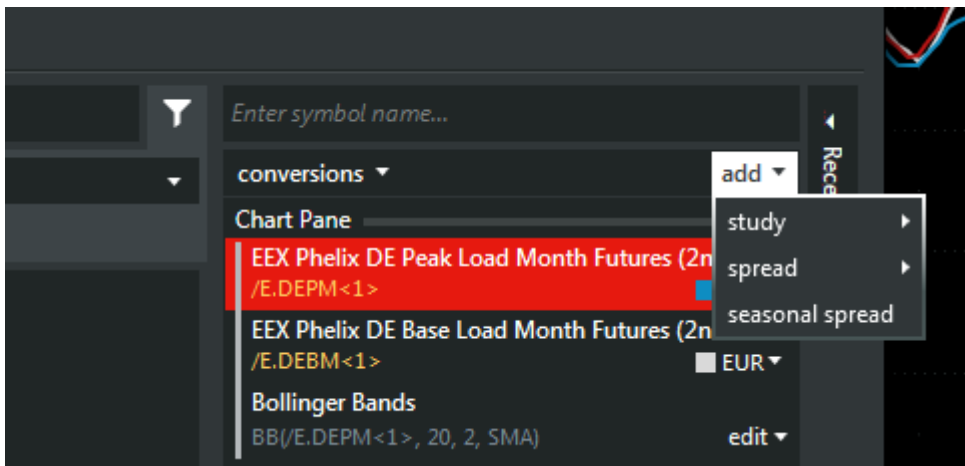

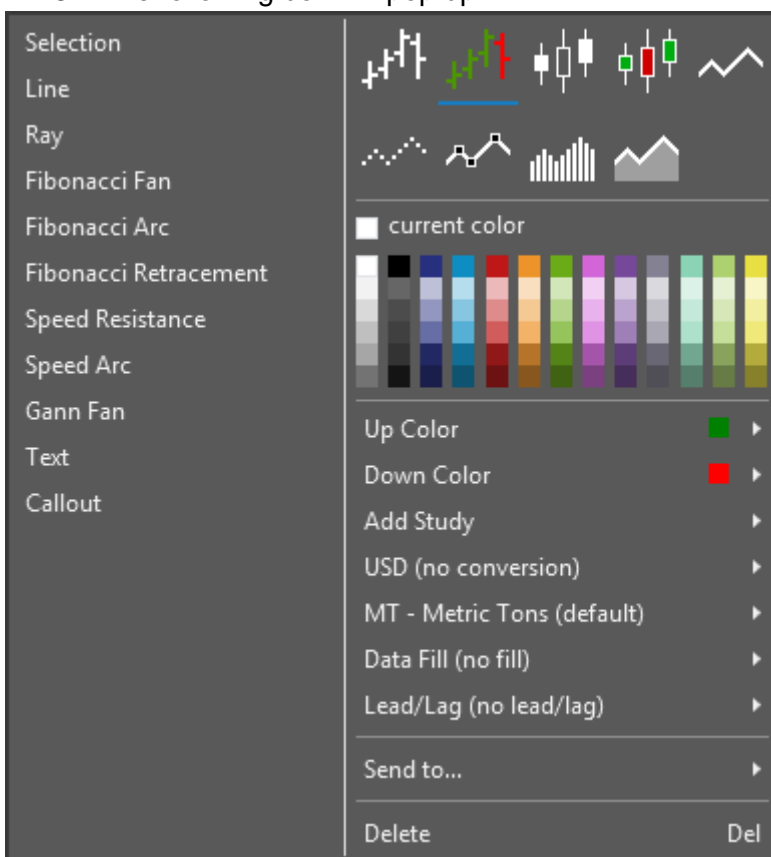

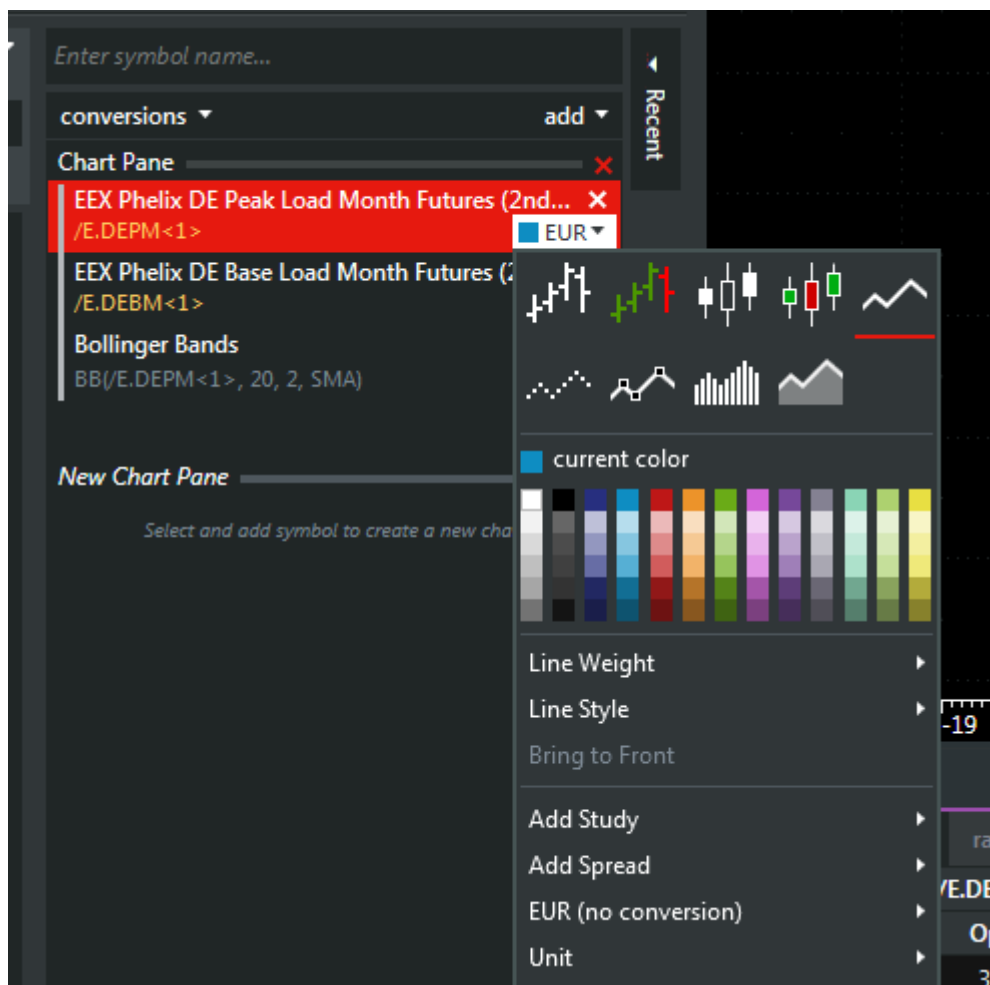

5.5 Charts Data Display

Once you have created a chart you will want to know how to read it and edit some of the characteristics. This section will point out



1. Edit	Use this button to access the edit chart dialog box. From here you can access the symbol tree, add/remove symbols, add studies and change line color.
2. Enter Symbol	Use this box to add a symbol to the chart. You must know the symbol name, if you dont use the edit button to search for a symbol.
3. Time Series	Use the drop down to select the frequency in which you want to see the data (daily, weekly, monthly, etc...)
4. Delete	Select a line or study and click delete to remove it.
5. Bring to Front	Select a line or study and click Bring to Front to place it over the top of the other lines.
6. Color	Select a line or study then use the drop down to select a color.

7. Line type	Select a line then use this drop down to select a chart type (bar, candlestick, dot, etc..)
8. Date Range	Use this feature to set a specific start and end date.
9. Show Statistics	This feature will display the min, max, mean, and standard deviation at the top of your chart.
10. Settings	Use the settings icon to change the fonts and colors within your chart.
11. X-Axis	Plots the date of the data.
12. Y-Axis	Plots the value of the data

5.6 Axis Settings

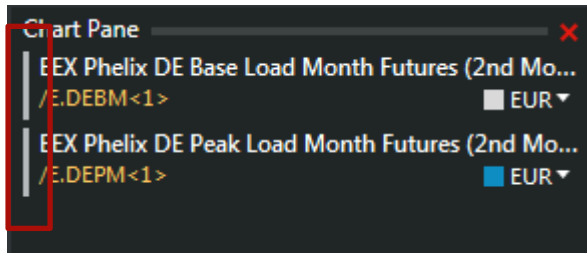
In your EEX Group DataSource Chart you can change the Y axis the line is plotted on to better compare the tickers. You may want to set both tickers to the right axis so you can accurately see the difference in prices. Another option is to set one ticker to the right access and the other ticker to the left access; this is best used to compare instruments with very different prices or units.



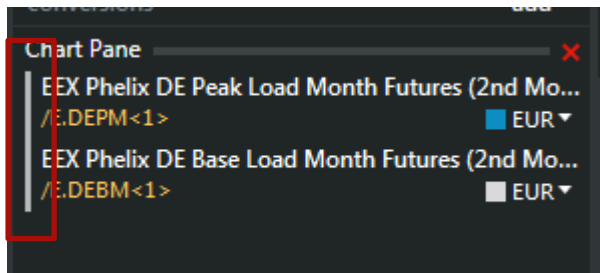
To change the Y axis the line is plotted on:

10. Alerts

Setting up an alert as follows:

- Open an Alerts window in your workspace by clicking the red underlined “ALERTS” tab at the top of your screen. All alert windows and controls are color-coded red for ease of identification.
- Double-click under the **Symbol** field to create a new alert. You will notice a checkmark in the “Enabled” column as well as a flashing cursor and dropdown menu appear.
- You can now type or paste your desired symbol into the **Symbol** field. Alternatively, the dropdown menu allows you to browse the symbol tree as well as your user-defined formulas.
- Designate the field that you would like your alert to monitor in the next column labeled **Field**. The **Above and Below** fields are used to set the values that trigger the alert. NOTE: As of the creation of this walkthrough, setting both **Above and Below** thresholds does not work. It is more reliable to set separate alerts for each.
- The **Frequency** field can be used to select whether the alert is only triggered one time or every time a contract trades within your alert parameters.
- If desired, type a custom message into the **Message** Field. If the Popup setting is turned on, your message will display in the popup window of your alert. Enabling the Speech option will read this message to you.
- Finally, if you would like a sound to accompany your alert – choose one from the dropdown menu in the **Sound** field.
- Your alert is now set and monitoring your selected field! For this example, when a NYMEX L.S.C.O Future is traded above \$45.00, the alert will display a pop-up window accompanied by a beep as shown below. NOTE: If you find that your alert is not functioning properly, first try clicking any field within the alert and pressing the “Enter” key on your keyboard.
